Aberdeen City Council (Anderson Drive**) Air Quality Management Area Order 2018 (Nitrogen Dioxide and Particles (PM₁₀))**

Amendment to Order Designating an Air Quality Management Area

Whereas Aberdeen City Council (“the Council”), having conducted a review and assessment of air quality in Aberdeen pursuant to section 82 of the Environment Act 1995, is satisfied that the air quality objectives in respect of the Nitrogen Dioxide objective specified in the Air Quality (Scotland) Regulations 2000 (as amended by the Air Quality (Scotland) Amendment Regulations 2002 and the Air Quality (Scotland) Amendment Regulations 2016) are not likely to be met in the area described in Part 2 of the schedule annexed and executed as relative hereto (the “Schedule”) for reasons both of the current and projected exceedance of the objectives.

The Council in exercise of the powers conferred to it by section 83 of the Environment Act 1995, hereby makes the following amendment to the Air Quality Management Areas designated in the Original Air Quality Management Order and thereafter amended by the Amending Order, both as defined in Part 1 of the Schedule.

IT IS HEREBY ORDERED THAT:-

1. The area shaded green on the attached map, annexed and executed as relative hereto (the “Map”) and also described in Part 2 of the Schedule, shall be known as the “Anderson Drive Air Quality Management Area”;
2. The Anderson Drive Air Quality Management Area is to be specific to (i) Nitrogen Dioxide by virtue of the likely exceedance of the annual mean objective and (ii) to Particles (PM₁₀) by virtue of the likely exceedances of the annual mean objective;

3. This order is to be cited as the Aberdeen City Council **(Anderson Drive)** Air Quality Management Area Order 2018 (Nitrogen Dioxide and Particles (PM₁₀));
4. This order shall come into force on 15 October 2018 and shall remain in force until varied by a subsequent order or otherwise revoked;
5. The Original Air Quality Management Order and the Amending Order shall no longer have effect;
6. A copy of this order and the Map may be inspected free of charge at Aberdeen City Council, Marischal College, Broad Street, Aberdeen AB10 1AB.

PART 1 – Former Orders

In the foregoing Aberdeen City Council (Anderson Drive) Air Quality Management Area Order 2018 (Nitrogen Dioxide and Particles (PM₁₀)) the following bear the following meanings:

1. the “**Original Air Quality Management Order**” means the Air Quality Management Area Order dated in or around December 2008, relating to Nitrogen Dioxide objectives in the Anderson Drive Air Quality Management Area or thereby.
2. the “**Amending Order**” means the Aberdeen City Council Anderson Drive Air Quality Management Area Order 2011 (Nitrogen Dioxide and Particles (PM₁₀)).

PART 2 - Description

The area shaded green on the Map incorporates the following:

- (1) All of Anderson Drive from Bridge of Dee, including Haudigan Roundabout;
 - (2) Part of Great Northern Road, from 815 Great Northern Road to Auchmill Road;
 - (3) Part of Auchmill Road, from Great Northern Road to the junction with Howes Road.
